**TERMS OF THIS AGREEMENT ARE AS FOLLOWS:**

Seller agrees to provide Buyer a fully transferable AKC Registration Certificate (Seller Registered) or AKC Application for Registration (Buyer Registered) to said dog. All of our litters are AKC registered.

Seller will take back the dog for any reason within the first 30 days with full refund of purchase price less veterinarian examination fees.

Seller agrees to replace with another dog of a different breeding if said dog is mutually agreed by Buyer and Seller to not be of sound health and is euthanized within two (2) years of age.

Seller has the right of first refusal if the buyer cannot retain possession of said dog at anytime in the future.

Seller agrees to authorize the "Application to Revoke Limited Status" AKC form, **if applicable**, upon receiving from the buyer a mutually agreed breeding plan. Buyer acknowledges said dog must be at least two (2) years old to be considered breeding age. **This is an option we discuss and is not mandatory.**

Buyer agrees to spay or neuter said dog if being purchased as a companion or family pet.

Seller agrees to provide medical records for said dog. Said dog has been vaccinated and wormed regularly. Next shots are due on \_\_\_\_-\_\_\_\_-\_\_\_\_\_. Buyer agrees to have said dog examined by a veterinarian as soon as possible. Buyer agrees to provide normal veterinary care and proper nutrition for said dog during the course of the dog's natural life.

Buyer agrees to keep in contact with Seller and the Seller agrees to provide any reasonable help or advice to the Buyer if requested.

Buyer is responsible for taking possession of said dog between 7-8 weeks of age. If Seller provides boarding of said dog after 8 weeks age a \$10.00 per day fee will be collected beginning on day fifty seven.

Buyer acknowledges they have spoken with the Seller and understands the selection process. Buyer acknowledges their deposit of \$ \_\_\_\_\_ is a guarantee of the Seller to provide a dog of the \_\_\_\_\_ sex. Seller does not guarantee any particular markings or color of said dog but will make every fair and reasonable effort to accommodate the Buyers preference upon inspection of the litter by the Buyer.

Seller will refund in full any deposit should Seller not be able to provide the agreed sex of dog.

Seller has the right to keep any portion of said deposit should Buyer decide to not commit to the purchase any time after the litter is one (1) week of age.
